THST reserve the right to refuse to distribute or publish on the website any statement which they consider to be defamatory or in any way detrimental to the interests of the Trust.

Each candidate will also be required to make themselves available for a conversation with existing board members between Wednesday 31st January and Thursday 8th February, 2018.

NOTES

1 Eligibility criteria, rule 58:

No person can be a member of the Society Board who:

- a) has been a member of the Society Board for 12 consecutive years
 - b) has been declared bankrupt or compounded with their creditors
 - c) is subject to a disqualification order made under the Company Directors Disqualification Act
 - d) has been convicted of an indictable offence
 - e) in relation to whom a registered medical practitioner who is treating them gives a written opinion to the Society stating that they have become physically or mentally incapable of acting as a Director and may remain so for more than three months
 - f) in relation to whom by reason of their mental health, a court makes an order which wholly or partly prevents them from personally exercising any powers or rights which they would otherwise have
