NB: Under Rule 60, one third of the members of the Society Board elected by the members who have served the longest (since initial appointment or re-appointment) at the date of the Annual General Meeting each year will resign. If at any time there is an uneven number of elected directors or the number of elected directors is not divisible by three, the Society Board shall decide the number of elected directors to resign in accordance with this Rule, which shall be approximately one third of the total number.

On this occasion, two members of the Board resigned out of full cycle, namely Anthoulla Achilleos and Simon Sullivan. A third member, Koonal Shah, is stepping down from the Board at the AGM. Anthoulla was appointed as a Board Director in 2019, while Simon and Koonal were appointed in 2022. Anthoulla served as Vice Chair of the Trust between May and October 2023. We thank Anthoulla, Simon and Koonal for their contributions. Of the remaining Board members, the three who have served the longest since initial appointment or re-appointment are Michael Green, Martin Buhagiar and Steve Cavalier, all of whom were last appointed in 2021. The Board has decided that Steve Cavalier will resign. Steve is standing for re-appointment at the AGM.

For the re-appointment of Steve Cavalier to the Society Board, a simple majority of 51% will be required of those full members voting at the meeting or by proxy vote.

### ELECTION OF UP TO THREE NEW BOARD MEMBERS TO TRUST BOARD:

In accordance with the AGM timetable, the nomination period for full members wishing to stand for election to the THST Board closed on 19 January 2024.

Four places were available, and two nominations were received. Therefore, the two candidates will be elected to the THST Board, providing this is approved by the membership.

## **RESOLUTION TO DISAPPLY THE APPOINTMENT OF AUDITORS:**

Under Rule 82.3, in any year of account the Society shall not be required to appoint auditors if it is exempt under the Co-operative and Community Benefit Societies Act 2014 and has disappplied the obligation to do so in accordance with the Act.

Since the 2018 AGM, the Trust has disappplied the need for an auditor and instead has gone down the route of having an independent examination of the accounts conducted in respect of "small societies", as defined by the Co-operative and Community Benefit Societies Act 2014.

The resolution before you is that we continue to disapply section 83 of the Co-operative and Community Benefit Societies Act 2014 (the duty to appoint auditors) and appoint an independent examiner to examine the accounts for the year ending August 2024, to be shared with the membership at the 2025 AGM.

A simple majority of 51% will be required of those full members voting at the meeting or by proxy to pass this Resolution.
